

Amphetamine

was expected in **1** sample and detected in **0**.

Instead of **amphetamine**, this sample contained **MDMA**.

Ketamine

was expected in **18** samples and detected in **13**.

Purities ranged from **46 - 82%**.

1 sample also contained **MDMA** & **2** samples also contained **procaine**.

In the samples where **ketamine** was expected/wasn't found:

2 contained

procaine & tiletamine

and

1 contained **2'-fluoro-2-oxo-PCE**.

LSD expected in **3** & detected in **2** samples

3-Methyl-PCPy expected & detected in **1** sample

β-K-2C-B expected and detected in **1** sample

Deschloroketamine expected & detected in **1** sample

DMT expected & detected in **1** sample

Butane-1,4-diol expected & detected in **1** sample

Heroin

was expected in **5** samples and detected in **4**.

Purities ranged from **44 - 71%**.

In all **4** samples where **heroin** was found, **6-MAM** & **acetylcodeine** were also found.

2'-fluoro-2-oxo-PCE was detected in **1** sample where **heroin** was expected but wasn't found.

O-PCE

was expected and detected in **1** sample.

2'-fluoro-2-oxo-PCE expected & detected in **1** sample

MXiPr expected and detected in **1** sample

Pseudoephedrine expected in **1** sample (it was **paracetamol**)

Tiletamine expected in **1** sample (it was **procaine**)

2C-B

was expected in **3** samples & detected in **1**.

In one sample, **MDMA**, **ketamine** & **caffeine** was found instead.

In another, **dimethylpentylone** was found instead.

Cocaine

was expected in **34** samples and detected in **33**.

Purities ranged from **15 - 89%**

3 samples also contained **procaine**, **2** samples also contained **caffeine** and **1** sample also contained both **caffeine & lidocaine**.

Creatine was detected in **1** sample where **cocaine** was expected but it wasn't found.

Meth

was expected and detected in **6** samples.

Purities ranged from **53 - 80%**

MDMA

was expected in **54** samples, detected in **49**.

Samples tested & their purity ranges:

16/17 capsules contained **<5 - 82%**

4/5 pills contained **16 - 36%**

4/4 powders contained **8 - 33%**

25/28 crystalline contained **<5 - 83%**

1 **MDMA** sample also contained **ketamine**.

Where **MDMA** was expected/wasn't found:

1 sample contained **4-CMC**

Community News

CanTEST have tested a total of **1554** samples to 20th Oct 2023.

We provided **165** health and AOD brief interventions and **16/153** samples were voluntarily discarded by people after they received their results this month.

CanTEST continues to see a marked increase in purity for both **cocaine** and **MDMA** - people should start lower and go slower than usual to avoid accidental overdose.

This month, NSW Health released a warning regarding the usage of a drug expected to be **cocaine**, resulting in **heroin** overdoses.
