

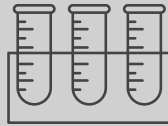
## Community News

CanTEST staff provided **142** health and AOD brief interventions and **13/139** samples tested were voluntarily discarded by people after they received their test results.

To 20 November, CanTEST had tested a total of **371** samples during the trial period.

CanTEST opened for extended hours in the lead up to Spilt Milk Canberra on 26th November and those results will be included in next month's snapshot.

## Heroin

was expected in and detected in **1** sample presented  
Purity was **58%**



## Ketamine

was expected in **23** samples and detected in **14**

Purities ranged from **31 - 70%**

In the samples where people expected **Ketamine** to be present but it wasn't found,  
**1** sample contained **cocaine**,  
**1** sample contained **dipentylone**,  
**3** samples contained **2'-fluoro-2-oxo-PCE (2F-NENDCK)** and **1** sample contained **procaine**.



## MDMA

was expected in **43** samples and detected in **34**

Samples tested & their purity ranges consisted of:

**14/17** capsules contained **<5 - 68%**  
**1/1** powder contained **56%**  
**0/3** pills contained **MDMA**  
**19/22** crystalline contained **18 - 84%**

In the samples where people expected **MDMA** to be present but it wasn't found,  
**2** pills contained **MDA** and **caffeine**,  
**1** pill contained **dextromethorphan**,  
**1** sample contained **MDA** and  
**2** samples contained **dipentylone**.



## Methamphetamine

was expected in **2** samples and detected in both.

**1** of these samples had a purity of **75%**.



## Cocaine

was expected in **19** samples and detected in **11**

Purities ranged from **<5 - 43%**

Cocaine adulterants found included **caffeine**, **creatine**, **glutamine** and **lignocaine**.

In samples where people expected **cocaine** to be present but it wasn't found,  
**1** sample contained **benzococaine**,  
**2** samples contained **boric acid**,  
**1** sample contained **glutamine**,  
**1** sample contained **urea** and  
**1** sample contained **lignocaine** and **dipentylone**.



## Other Findings

A range of other expected substances were detected, including **2'-fluoro-2-oxo-PCE (2F-NENDCK)**, **metandienone** and **trenbolone enanthate**.

**1** sample which was expected to contain **4-MMC** was instead found to contain **3-CMC**.

Of the **9** unknown samples which were presented to CanTEST;  
**4** were identified as **MDMA**,  
**2** were identified as **cocaine** and **1** was identified as **lactose**.
